In 2010/2011 Blue Ridge Literacy Council volunteers tutored 185 adult students, 58 were tutored in the Basic Literacy Program and 127 in the English as a Second Language(ESL) Program. 97% percent of students with 12 or more hours increased their literacy skills enough to accomplish one or more of the life changing goals they set for themselves, such as: getting a better job, entering a higher education program, becoming a US Citizen, helping children with schoolwork, etc. In 2010/2011 BRLC volunteers contributed 15,226 hours of service which reflects an economic donation of over \$325,000 to the community.
