

In 2011/2012 Blue Ridge Literacy Council volunteers tutored 189 adult students, 59 were tutored in the Basic Adult Literacy Program and 130 in the English as a Second Language(ESL) Program. A total of 141 tutors and other volunteers generated 16,084 hours of service (which is the equivalent of 7.7 full time employees) and the value of contributed hours, as determined by the Independent Sector, is \$350,470.
