

In 2012/2013 Blue Ridge Literacy Council volunteers tutored 220 adult students, 63 were tutored in the Basic Adult Literacy Program and 157 in the English as a Second Language(ESL) Program. A total of 143 tutors and other volunteers generated 15,479 hours of service (which is the equivalent of 7.44 full time employees) and the value of contributed hours, as determined by the Independent Sector, is \$342,705.
