In 2014/2015 Blue Ridge Literacy Council (BRLC) served 185 students through the Adult Basic Education and English as a Second Language program. Students worked with 113 trained volunteer tutors to increase their literacy skills including writing, reading, pronunciation, basic math, computer/digital literacy, and health and workplace literacy. 73% of our students maintained or sought employment with 50 also working towards their GED or college preparedness. 70% of those we served were women. Volunteers donated 15,324 hours, the equivalent of 7.37 full-time staff members. BRLC is the only Henderson County nonprofit providing resources and one-to-one literacy instruction at no cost for adult learners.
