In 2015/16 Blue Ridge Literacy Council (BRLC) served 188 students through the Adult Basic Skills and English as a Second Language programs. Students worked with 117 trained volunteer tutors to improve their English communication skills or increase their literacy skills including writing, reading pronunciation, basic math, computer/digital, health and workplace literacy. 81% of students sought to improve their socio-economic well-being of which 32 increased their income, 13 got a job, 12 improved their ability to seek employment, and 55 were able to retain employment.

Additionally, 7 students enrolled in the GED program, 3 obtained their GED, and 1 enrolled into a post-secondary program. In total 98% of our students achieved 1 or more of their goals and 52% of those students who were pre and post-test gained one or more federally established literacy level. 70% of those we served were women. Volunteers donated 14,665 hours, the equivalent of 7 full-time staff.
