Adult Tutoring is provided by trained volunteers in a one-on-one or small group setting for both native and non-native English speakers in the context of his/her goal(s). Such goals can include acquiring: a high school diploma certificate, professional certifications, college entrance, citizenship, and financial stability through workplace related goals. Annually we serve 150-175 individuals through our tutoring program.

Program Two:
Corrections Education is provided to detainees at the Henderson County Detention Center. Classes focus on improving literacy and communication skills in the context of positive life skills and work development. The 2017-2018 year was our first year offering this program, and we served approximately 100 detainees.

Program Three:
Our Family Literacy program is a multi-generational English Acquisition Program for parents who have children 0 -5 years of age. The program teaches parents English in the context of parenting skills and child development education while teaching the children English through educational play and ensuring the children learn pre-literacy skills. We served 41 adult participants and 45 children in 2017-2018.
